Company Searches

Registered Office £Free

Provides you with the registered office address of the company, registered number and incorporation date also the company's accounting reference date.

Filing History Report £Free

Provides you with a list of all filing which has taken place on the company and gives you the opportunity to request selected documents that may have been filed and which you need to see in more detail.

Company Appointments Search £7.50

Provides you with the current and past officers of the company showing dates of appointments, resignation and residential addresses of officers.

Director and Secretary Search £7.50

Listing only. Provides you with a list of companies that the director has personally been appointed to with and any changes of address the director has notified to the Registry.

Copy of a Filed Company Document £8.00

Provides you with any individual document filed at Companies House. This could be an appointment, resignation, legal charge or even a revised memorandum. ANY document filed with the registry.

Mortgage Index £5.00

Provides you with information as to whether a debenture or legal charge has been made against the business.
